Lana Sneddon has owned and managed Stonecrest Farm, a top breeding and training facility for more than two decades. Lana has conditioned, trained, and shown young horses for inspections, breed shows and performance test. She has been a KWPN/NA judge since 2002, and has served on the KWPN/NA advisory board, as well as, hosting performance tests.

Being a 10-year 4-H horse and Pony member laid the foundation for training horses of different disciplines leading to numerous regional and national titles over the years. Lana has trained with Michael Poulin, Christine Traurig, Uwe Steiner, Tom Poulin, Michael Etherly, Yvonne & Kim Barteau, and Dana Haxeleger to name a few.

In 2005 Lana was invited to the Markel/USEF FEI young horse championships with Tamora SCF, a 5 yr old mare that she bred and trained. In 2006 she trained and showed two - 3 yr olds who finished the season in the USDF materiale end of the year awards. Winetta SCF placing 4<sup>th</sup>(78.5%) and Grafix Tex placing 3<sup>rd</sup> (80.0%). In 2007 she trained another 3 yr old, Zen Rosa who finished in 7<sup>th</sup> place in the USDF materiale end of the year awards. In 2008 yet another successful year for Lana, aboard the home bred and trained Armani SCF who received the prestigious year-end award of Champion of the 3 yr old DG Bar Cup. In 2009 Lana & Armani defended their DG Bar Cup championship in the 4 yr old division and also qualified for the Markel/USEF FEI young horse program with only two classes.
